Marion County Job and Family Services (MCJFS) may be able to assist.

A limited number of School Resource Kits are available to assist K-12 students with the online portion of their schooling. The School Resource Kit includes:

1. Lap Desk (does not include computer)
2. Wireless Mouse
3. Headset
4. Walmart Purchase (not to exceed \$100.00/student)

**To Qualify:**

**Applicants must live in Marion County & have a child/ren attending an online class through Marion City or County Schools (K-12). Applicants must meet income guidelines (200% FPL, see table below).**

Applications will be posted on our website at [mcjfs.com](http://mcjfs.com). Please complete the application and email to [Sarah.Armstrong@jfs.ohio.gov](mailto:Sarah.Armstrong@jfs.ohio.gov). Please ensure all information is current and accurate before submitting your application. A limited number of kits are available, the application process will close unannounced when all the kits have been issued.

Once the application is received a case manager will call to verify the information. This is a one-time issuance; resources are limited to assist students enrolled in K-12. Please note, this is a first come first served process.

**Please Note:** All School Resource Kits will be issued from MCJFS. Available times for issuance are on the application, select the time that best fits your schedule. All Walmart purchases must also be scheduled. The available dates and times are listed on the application, please select one of the times that best fits your schedule. We will have an MCJFS Representative at Walmart to help complete the purchase. Please make sure you are available at the time selected. If a parent is unavailable, they can designate a substitute. The name must be added to the application and they must provide picture identification.
